- 3) Curriculum of the State or respective Board will be compulsory from 1st to Vth Std.
- 4) Marathi language subject will be taught up to VIII std.
- 5) The State Govt. reserves the right to withdraw the above certificate at any time without giving prior notice and without assigning any reason if any deviation of rules reported in future and the management fails to comply with the instructions of the State Government.
- 6) Staff salaries should be paid as per Govt. Pay Scale.
